The Undersigned agrees, if written notice of the acceptance of this bid is mailed, telegraphed or delivered to the Undersigned within sixty (60) days after the date of opening of bids or any time thereafter before this is withdrawn, to execute and deliver a contract as described in the "Instructions to Bidders" within eight (8) days after date of mailing, telegraphing or delivery of such notice.
